CITIZENSHIP OF ANTIGUA & BARBUDA

BY INVESTMENT PROGRAM

The Antigua & Barbuda Citizenship by Investment Program is launched for investors, individuals, and their families to directly acquire alternative citizenship and a second passport. This program requires a financial commitment of at least USD 100,000 government donation (The National Development Fund), or a minimum USD 200,000 investment in real estate. Moreover, Antigua & Barbuda offers a special investment option to families of six and more to get life time citizenship by contributing a minimum amount of USD 150,000 to the University of the West Indies Fund. Considering this option, Antigua & Barbuda is the most affordable citizenship program among Caribbean CBI programs for large families. They can not only obtain citizenship by spending less money but also one family member can study for one year in the university free of charge.









The government of Antigua and Barbuda requests each new citizen to spend 5 days on the island during the 5 years period in order to get acquainted with the local culture.



Investment options are as follows:

1. Contribution to the National Development Fund

A. For a single applicant, or a family of 4 or less \$100,000

Processing fees: \$30,000

Due Diligence fee: \$7,500 per applicant or spouse

\$4000 per adult family member \$2000 per child 12 to 17 years old

B. Family of 5 or more: \$125,000

Processing Fees: \$ 30,000 plus an incremental amount of \$15,000 from the 5th

dependent onwards. Plus Due diligence fees.





2. Contribution to the University of the West Indies (UWI) Fund

A. For a family of 6: \$150,000 \$15,000 for each additional dependent Plus Due diligence fees.

3. Investment in a government-approved real estate project

Minimum investment of USD 200,000 The property must be held for 5-years.

Processing Fees: \$ 30,000 Plus Due diligence fees.



4. Business Investment

- -Invest \$ 1,500,000 in an approved business as a sole investor
- -Invest \$ 5,000,000 as a joint business investment with a minimum of \$ 400,000 for each individual threshold
