# BY INVESTMENT (CBI) PROGRAM

The Dominica Citizenship by Investment Program was introduced in 1993 by the Government of the Commonwealth of Dominica, allowing foreign investors to acquire citizenship under certain conditions. This is now one of the world's longest-running economic citizenship schemes and one of the most reputable. Applicants obtain irrevocable citizenship and passport without having to reside in the country or renounce their current nationality.



Individuals applying for the Dominica Citizenship by Investment (CBI) program can make their financial contribution one of two ways:

























### **Economic Diversification Fund**

The Economic Diversification Fund (EDF) supports public and private projects within Dominica, covering industries such as education, healthcare, sport, and tourism. A single applicant must contribute \$100,000 to the EDF, though fees will increase if they wish to apply for additional dependents to join them in Dominica.

### Real Estate

To qualify for Dominican citizenship under the real estate option of its Citizenship by Investment program, you must purchase authorized property worth at least \$200,000. Real estate must be held for either three years from the date your citizenship is granted or, if the future purchaser is also citizenship by investment applicant, five years from the date your citizenship is granted.

Full citizenship granted to the applicant and included family members as a spouse, children under 25 years old, parents and grandparents at the same time.





3.


