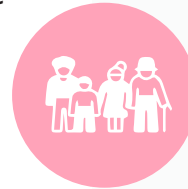

HOW IT WORKS, THE PROCESS..

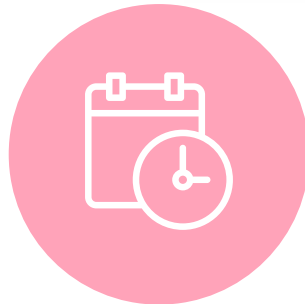


1.

Along with the applicant's condition, we ask for the required documents. All the documents need to be translated into the language which is needed. Regarding the applicant's nationality, they also need to be apostilled or legalized.

2.

Before proceeding with the D-type visa application, applicants will be required to Deposit a sum of no less than EUR 500,000 in a Monaco bank and purchase or rent property in Monaco. Our team will be on hand to assist you with bank account opening and property searches.



3.

All the relevant documents will be collected under the supervision of our lawyers, and they need to be officially translated and notarized.

4.

We complete the required applications and book an appointment with the French Consulate or Embassy in the applicant's home country.

5.

The applicant will attend the Consulate or the Embassy on the specified day and an interview may be conducted.





6.

If the application is approved, a D-type visa will be issued for the applicant and the dependents.



7.

We will plan a journey to Monaco to apply to the Monegasque authorities (Residents Section of the Directorate of Public Security) for a Carte de Séjour.



8.

All applications must be submitted within 8 days of arrival to the Principality. Our team will work with you to ensure that you are able to satisfy all documentary and legal requirements before applying and can assist you with property acquisitions as needed.



9.

Residence cards will be issued.
