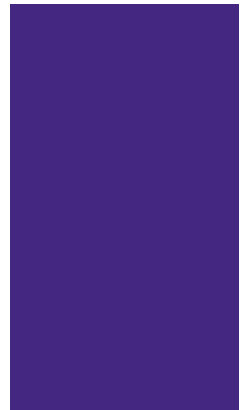

The UK's stable economic system, extensive legal structure, and diverse consumer market make every entrepreneur dream of starting up a UK business. Creating or funding a new start-up company is a very attractive option for skilled individuals to access the European market with over 500 million consumers. Moreover, a UK visa through business investment is the most straightforward path to UK residency and provides a route to British Citizenship.



On 17 February 2021, the British government closed the Tier 1 (Investor) visa category to new applicants with immediate effect and two other investment routes remain applicable. By investing in or taking over a business in the United Kingdom, you can be entitled to take up residence, along with your family. Applicants are required to demonstrate an innovative, viable, and scalable business idea and at least £50,000 to invest in their business. Furthermore, Applicants must spend at least 183 days per year in the UK.





INVESTMENT OPTIONS

1. Innovator visa

You must be able to show that:

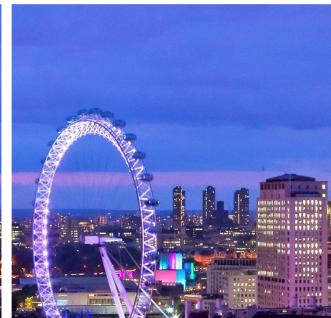
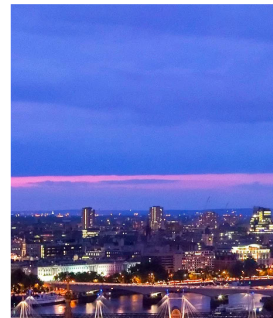
- Your business idea is new and innovative with the potential for growth
- You meet the English language requirement B2 level
- You have enough personal savings to support yourself and your family
- You will invest at least £50,000 in your business
- You need to have at least £1,270 in your bank account for 28 consecutive days



2. Sponsorship Visa

You must be able to show that:

- You have already run your business in the UK
- You will have a hands-on role in the business development based on your viable business plan
- You have enough personal savings to support yourself and your family

PROCESS AND TIMELINE

HOW IT WORKS, THE PROCESS..



1.

We will assist investors with the most reasonable and convenient business registration, and we ask for the required documents. All the documents need to be translated into English. Regarding the applicant's nationality, they also need to be apostilled or legalized by the Consulate or the Embassy of the UK.



2.

Applicants with innovative business ideas who wish to establish their business in the UK and do day-to-day management can request a three-year residence permit to enter the UK. On the other hand, we can open a business bank account, hire employees, rent an office, etc. as per the applicant's request. In this case, applicants are allowed to apply for a five-year residence permit through the UK Embassy or Consulate located in their country of residence.



3.

Accordingly, The applicant will attend the appointment on the specified day in the UK Embassy or Consulate and an interview may be conducted.



4.

Applicants will need to undergo a medical examination and submit biometric data.



5.

Applicants may apply for Indefinite Leave to Remain (permanent residence) after 3 years subject to meeting minimum business performance requirements.
