HOW IT WORKS, THE PROCESS..

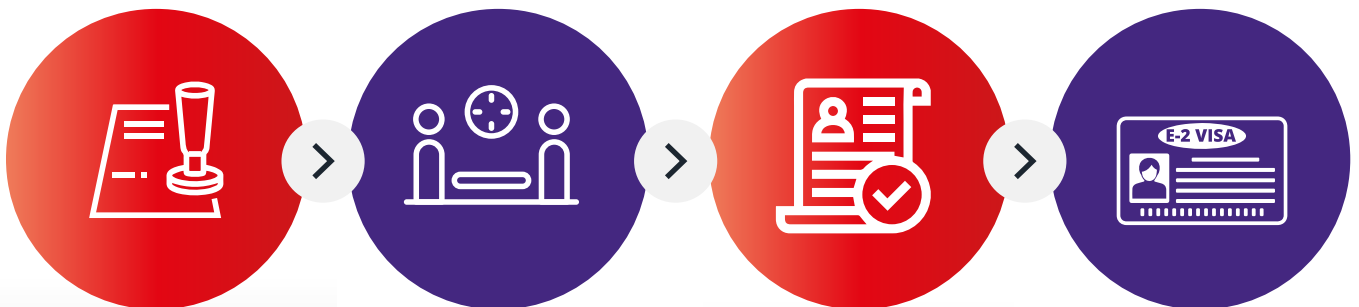
